

The battery can be charged only when it is removed out of the appliance.

Mains operation

Power supply through electrical connection.

Battery operation

Power supply from battery. Only one battery is required for operating the device.

Battery is empty or has not been inserted

- Indicator lamp of the empty battery blinks
- Appliance automatically shifts to the charged battery mode.

Both the batteries are empty

- Both the indicator lamps blink for 30 seconds.
- Appliance switches off.
- Mains operations are possible.

Cleaning

We recommend that you use a filter bag.

Note

We recommend that you operate the appliance in the mains mode while cleaning textile covering because of the high cleaning power that is required for such jobs.

- → Charge the batteries.
- No battery is inserted
- → Insert the battery.

In mains operation

- Power supply cable is faulty
- → Inform Customer Service

If malfunction can not be fixed, the device must be checked by customer service.
